5.1 Members

The Members of the Club shall consist of:

- i. Life Members, who are subject to this Constitution, shall have the right to receive notice of General Meetings and to be present, to debate and to vote at General Meetings;*
- ii. Individual Members, who are subject to this Constitution, shall have the right to receive notice of General Meetings and to be present, to debate and to vote at General Meetings; and*
- iii. Junior Members aged 16 years or older, who are subject to this Constitution, shall have the right to receive notice of General Meetings and to be present, to debate and to vote at General Meetings; and*
- iv. Junior Members under the age of 16, who are subject to this Constitution, shall have no right to receive notice of General Meetings and no right to be present or debate or vote at General Meetings; and*
- v. A parent/guardian of any junior Member under the age of 16 is considered a Member in his or her own right, who are subject to this constitution shall have the right to attend, participate and vote at a General Meeting.*

15.2 Form of Nomination

Nominations must be either:

- a) in writing;*
- b) on the prescribed form (if any) provided for that purpose;*
- c) signed by two Individual Members;*
- d) certified by the nominee (who must be a Member) expressing his willingness to accept the position for which he is nominated; and*
- e) delivered to the Club not less than seven (7) days before the date fixed for the annual general meeting.*

Or

- (a) emailed by the candidate (who must be a Member) to the official email address of the club;*
- (b) include the names and contact details of two (2) supporting Individual Members;*
- (c) include statement by the candidate expressing his willingness to accept the position for which he is nominated; and*
- (d) be received not less than seven (7) days before the date fixed for the annual general meeting*

Notice of all nominating candidates shall be circulated prior to the date fixed for the annual general meeting.
