Our competition coordinators Rachel Rice and Teegan Rodgers (Juniors and Mini Touch) which we provided the club with a new look season of Mini Touch comp with players allocated to teams (thanks to Teegan and her helpers), and Chris Reynolds (seniors) for a successful competition. These 3 people have spent countless hours setting up draws, group chats, and managing people's requests and complaints, a lot of tireless work in the background that people don't see so thank you very much for your time during the year.

Our committee members (Sonia, Bronwyn, Rachel Rice, Rachel Kelly, Danielle, Teegan, Luke and our volunteers (Ang, Brooke, Mick, Crush, Nick) that helped out week in and week out in running the canteen and cooking the BBQ the committee and club appreciated you for your time. To Rachel Wykamp (Kelly) for all your media posts during the year in promoting our club, your wonderful Facebook posts, and weekly draw updates this was a critical role in the club as this was the main way the club communicated with the community, thank you.

During the season we had some crazy weather with storms and extremely hot weather over 38 degrees, which resulted in the committee to run double header rounds during the normal season. Again, we were forced to play away from our newly renovated Cheney Park clubhouse, and we appreciated the support from the soccer committee for allowing us to use their facilities during the year. (Parker-Stone and Harrison fields).

We changed the season up with some new ideas at the start of the season. One was trying to finish the season with Grand final day on a Sunday as a family day and having all juniors and seniors playing on same day. Nevertheless, did it work, not sure but we tried something new. So looking at our local comp, we had 34 Junior teams (+ 12 being mini touch teams = 90 kids) = 360 registered junior players, 29 senior teams = (300 registered players), registered players for our juniors/senior local comp in 2023/2024 were = 740 players registered. Also thank you to our sponsors for their kind donations and their assistance and support of Parkes Touch throughout the year, the Parkes Shire Council for ongoing support and assistance (field marking, having facilities cleaned and working with us if problems raised)

Also, a massive shoutout to all our referees, who each week show up and this is why we can run our local competition each week. We have made good progress in developing our own referees for our local comp which resulted in over 38 referees officiating each week in junior /senior comp and even some of junior referees helped in the senior comp. As a club we need to focus on is trying to development our own referees to assist our rep teams when going away to rep carnivals. This year we had some great support from our referees which were (Chris, Cody, Lachlan Reynolds, David, Charlie Robinson, Cody Wakefield, Rachel Brown, Henry Rice and Alana Finnegan all of these referees were the reason our rep teams had the opportunity to go to these carnivals.

As for our rep teams the club made the decision to request for permission from NSWTA to play in the Northern Conference for the next 3 years, which this year was in Dubbo instead of the Southern conference in Wagga which is a big help financially for the club. This was very successful so a big thanks goes to Rachel Rice for all her work to make that happen. Our association is highly regarded in Suns and also by NSWTA which is a credit to be involved in, as I seen this at the NSW Touch conference people were well aware of Parkes Touch Association.





The committee again have worked tirelessly in organising managers, coaches, players, and so much more. To all our coaches and Managers thank you for your time each week during training and organising your teams. Each carnival requires setting up of our tents so thanks to those people who have assisted in these duties. To our rep co-ordinator Rachel Rice this role takes so much time to organise all Team sheets, ensuring the correct paperwork is completed by all players, checking Coaches/Managers have correct qualifications that meet NSWTA guidelines, ordering of uniform and answering all questions asked by people, organising accommodation for teams, travel plans, and team payments. To all coaches, managers, and our players for their commitment and conduct both on and off the field, so Rachel thank you for your time in this role.
